1. Update on GPAC Member Composition

Taylor Bateman updated the GPAC members on the composition of the committee due to Council elections and appointment changes for the Planning Commission and Parks & Recreation Commission.

2. "Mobility 101" – Presentation and Discussion

Bill Wiseman and Frederik Venter from Kimley-Horn and Associates led a presentation and subsequent discussion regarding current trends and laws regarding mobility and methods of traffic and circulation analysis. They also discussed current traffic conditions at key intersections and along Highway 17 and arterial roadways in Scotts Valley.

Following the discussion, GPAC members were asked to provide input regarding topics that should be addressed in the Mobility Element of the General Plan update. Suggestions included; pedestrian and bike connectivity, the possibility of a shuttle, jump bike and scooter policies, realignment of the Granite Creek overpass, grant funding opportunities, signal control and interconnectivity, and maintenance of private roads.
